INFORMATION FOR NEW MEMBERS:

A person 18 years of age or older may be considered for membership in the Club subject to the following conditions:

The prospective member must be of suitable character and interest and **must be sponsored by two current Club members** (include membership number on form) in good standing.

- If the prospective member **cannot supply two sponsors**, they **must complete** an interview form in person at the Club Office during regular office hours (see office hours listed below).
- Membership at Cherokee is a family membership, which entitles the member's spouse and dependent children who are not in the work force to use the Club's facilities under the rules & regulations set forth by the Board of Directors (a copy of Club rules will be provided upon acceptance).
- **All members** are required to perform 4 hours of eligible and verifiable Club service each year. If you are unable or unwilling to do so, you are required to pay a \$20 yearly maintenance fee.
- Every prospective member must fill out this application. You may join for **2019** any time after December 1st of **2018**. We do not prorate dues, due to our gate locks.
- **The expiration date for 2019 membership is February 28th of 2020**. If you do not renew your membership within 12 months of the expiration date, you will have to submit a **New Member application** for approval and complete the SWT again.
- Upon receipt of your application and the correct dues amount, you will be presented for approval at our next regular Club meeting. You do not have to be present to be approved.
- **NOTE: YOU WILL ONLY BE CONTACTED IF YOUR APPLICATION IS NOT APPROVED.**
You may call 423-357-5470 after meeting night to check on the status of your membership.

REQUIRED SAFETY WALK-THROUGH (SWT) - CLUB OFFICE HOURS:

- New members must attend a regularly scheduled Club SWT of Club facilities before you receive a membership card/gate key.
- **All SWT's are done after you are accepted for Membership.**
- The required SWT's begins at 2:00 PM sharp (sign-in at 1:45 PM) on the 2nd & 4th Sundays of January, February & March and 2:00 PM sharp (sign-in at 1:45 PM) on the 2nd Sunday only of April through November, **No SWT on Mother's Day or Easter see website for dates.**
- There are no SWT's held on major holidays or holiday weekends unless otherwise noted on the Club calendar (*check the Club website at cherokeerodandgunclub.com*).
- Regular office hours are the 1st Thursday of each month (meeting night), 1:00 to 6:00 PM.

MEMBERSHIP DUES & MAINTENANCE FEES: (All dues and fees must accompany application)

- **\$95** 2019 dues for ages **18 to 64 years** or **\$115** (if 4 hours Club service is not performed).
- **\$66.50** 2019 dues for ages **65 to 74 years** or **\$86.50** (if 4 hours Club service is not performed).
- **\$19** 2019 dues for ages **75 years & older** or **\$39** (if 4 hours Club service is not performed).
- For age 65 and older, proof of age is required when mailing the application or renewing in person. (Example: include a copy of your Driver's License or other positive identification).
- **Note: Extra Gate Cards are an additional \$2.00 each. Each person getting a card has to do a SWT. 16 & 17 year olds also has to have a Hunter Safety Training certificate on file prior to the SWT.**
